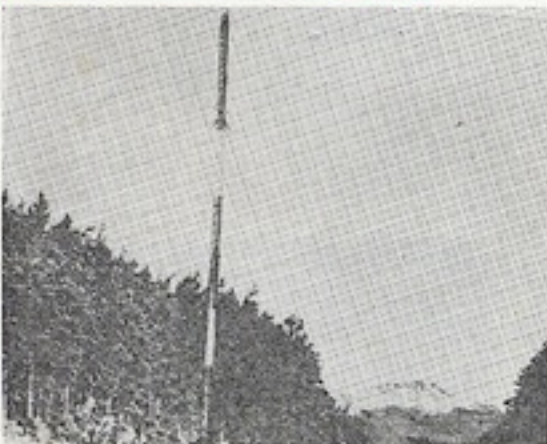

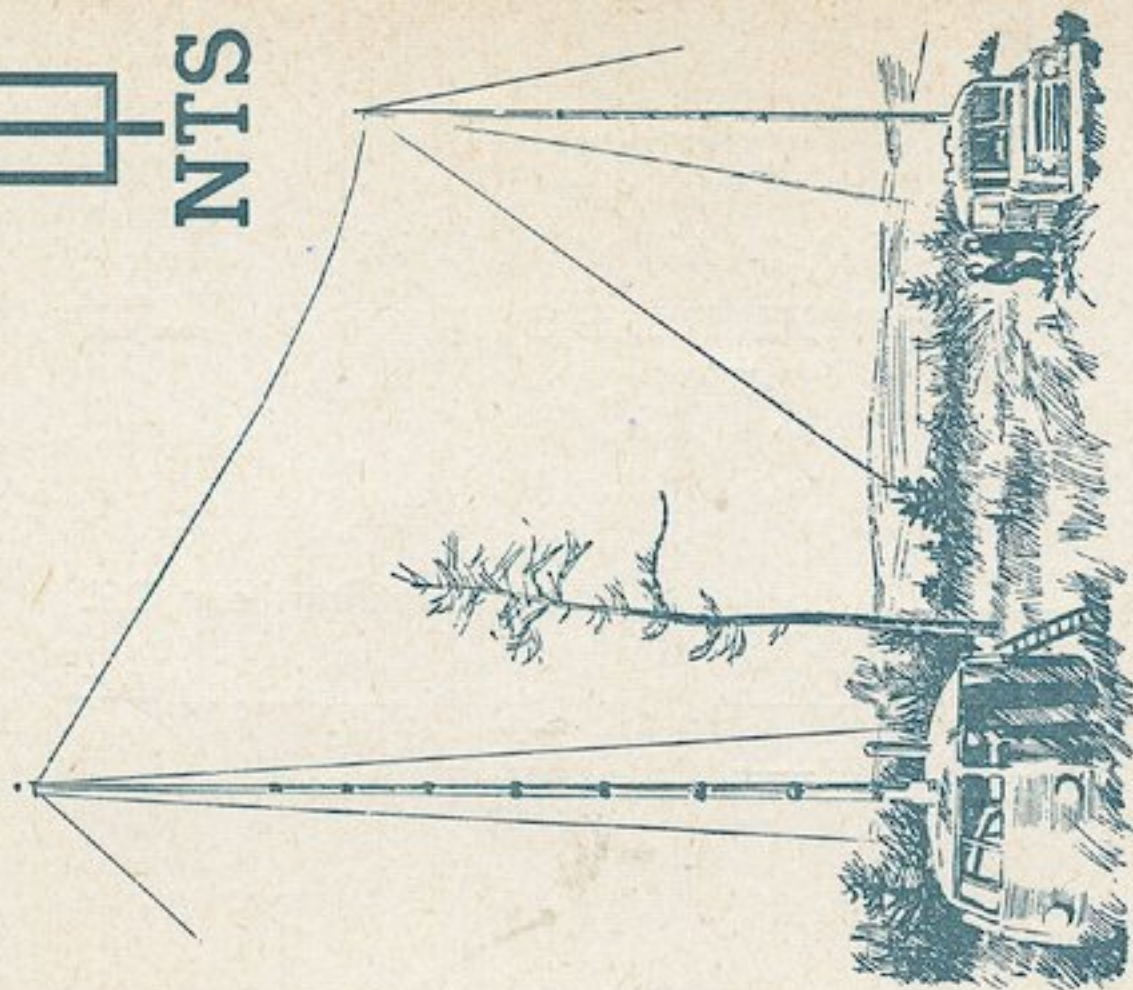

Thank you for your letter of Jan. 20, 1996. We very much appreciate the information you provided about yourself and your area of USA.

Yes, as you indicated, we had a program on WHRI radio transmitter in 1995. However, only after a few months of transmission we cancelled our contract with WHRI because of poor reception in the target area.

Our target area is the Horn of Africa. There live the Oromo people. See the enclosed brochure for more information.

At present we are transmitting from Europe and the Middle East on 5960 KHz at 16 hours UTC on Mondays, Wednesdays and Saturdays. Our program is being received in North-east Africa (target area), Middle East, west and southern Europe and Australia. Perhaps, you are too far away to receive our transmission. For more information we have enclosed SBO brochure.

If you could provide us with information on individuals, groups and organizations who are interested in financially supporting the kind of work we engaged in, ie. try to reach the voiceless people, we will very appreciate. We thank you most sincerely for your letter of 27 January 1985. It was a pleasure to note that our programme is received so far afield, although in technical terms it is not intended for transmission in your area.

We hereby verify that the frequency and times of transmissions that you recorded are correct for our English language service. A transmission in the vernacular is also made on the same frequency from 1700 to 1730 GMT.

The main purpose of this station is to propagate an alternative point of view to the propaganda put out by the government-controlled media in Zimbabwe. To provide further details of our intent, we attach a copy of the relevant portion of our broadcast on 8-10 September 1984 which we believe to be self-explanatory.
