

Our engineering department has been quite pleased, but overwhelmed by the many DX reports that continue to come in from all over the globe! Our busy schedule has not permitted us to answer so many reports in a timely manner.

This letter is to confirm your reception of WCMQ-AM 1700 on the expanded band. WCMQ operates with 10,000 watts during daylight hours and 1,000 watts at night using a non-directional antenna system located just outside the city of Miami, Florida USA. We are using a new Harris DX-10, 10KW digital AM transmitter and broadcasting in C-Quam AM Stereo. The station operates 24 hours a day in Spanish, serving all of Southeast Florida (ground wave).

We appreciate your reception report very much as it helps us determine how well the new facility is operating.

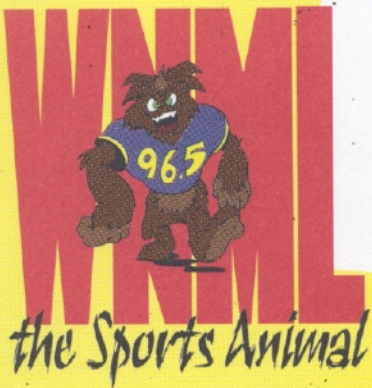




Dear Jerry,
